The student has a right to cancel and obtain a refund by submitting a *written notice*, *prior to the enrollment end date. The written notice must be sent to*:

Once notice is received, refund will be assessed in the following manner:

The student has a right to a full refund of all charges less than amount of \$250.00 for the registration fee and any other non-refundable items if he/she cancels this agreement prior to or in the first day of instruction or the seventh day after enrollment whichever is later. The amount retained for the registration fee may not exceed two hundred fifty dollars (\$250.00). In addition, the student may withdraw from a course after instruction has started and receive a pro-rated refund for the unused portion of the tuition and other refundable charge if the student has completed 60% or less of the instruction.
